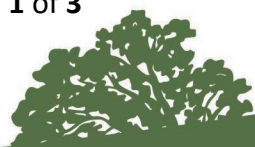
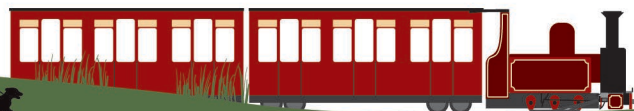
STANDARD CONDITIONS	This document contains our Standard Conditions which apply to everything we do.

## Use of our premises

- Smoking is permitted only in the car park by the designated smoking area sign
- Barbecues, fireworks and any aerial devices are not allowed without prior written consent
- dogs in harness or on a lead are allowed, please clear up after them – we will provide water
- Behavior must be lawful, responsible and unlikely to annoy other visitors
- Picnics are permitted anywhere on site except in our cafe; please take your litter home with you to keep Perrygrove tidy
- Bicycles, scooters and roller skates are not permitted onsite, including the car park – arrival by Bicycle is of course permitted.

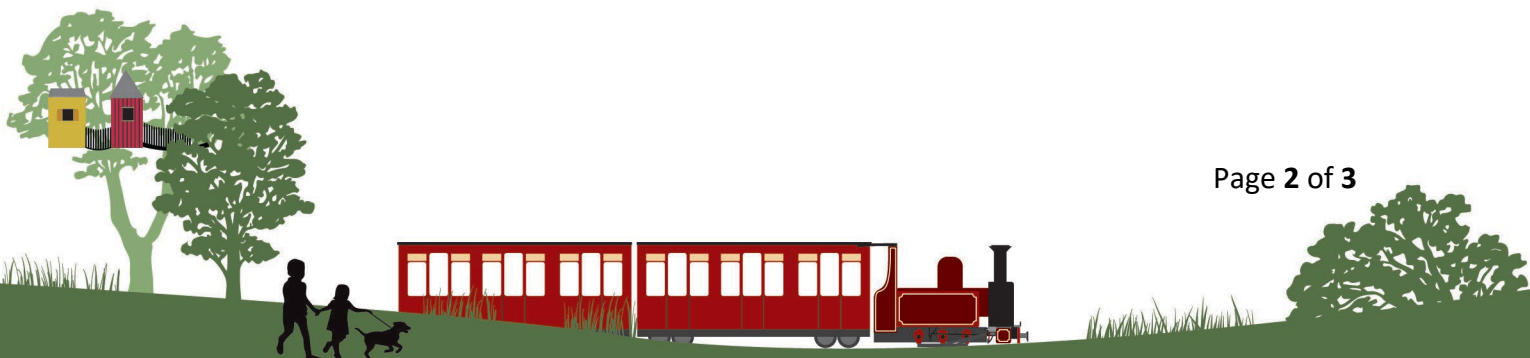
## Safety

Cross the railway only in the designated places. Do not walk along the railway line. You must be willing to accept the following entirely at your own risk:

- Occasional emission of soot, ash and sparks from steam locomotives
- Trip and slip hazards on uneven paths
- Low ceilings and/or stairs and other hazards in the Twilight village, on the footbridge, on the Treetop Adventure, Warren Adventure and other areas.
- Loss of or damage to any property, (including vehicles and equipment), brought on to or left on our premises

## Children

Any child who visits Perrygrove must be in the care of a responsible competent adult, who will supervise them properly and take care of them throughout their visit. Groups of children must be supervised by an adequate number of adults. The group organizer must assess how many adults are required. You must obey any age restrictions which are displayed close to play equipment.

## Train rides
